

**Live & Learn Early Learning Center/ Live & Learn @ Mast Way  
Parent/Guardian's Agreement**

I consent to the enrollment of my child with the Live & Learn Early Learning Center/ Live & Learn @ Mast Way and agree that in the case of sickness or injury of this child while in attendance of the center or in transit to and from, the center shall not be responsible, with the expectation that Live & Learn will take all the necessary precautions for his /her safety and well-being.

I agree to pay the weekly fee by Monday of each week. I have read the family handbook and agree to adhere to family guidelines and the policies and procedures of the center. I have been given an orientation to my child's classroom and have been given the opportunity to visit and play as much as my child needs to get acquainted. I have been introduced to staff and given a tour of the center and have been given the opportunity to ask questions that I may have.

Daily all children will be taking nature walks around the property and outside of the gated area. If I arrive after 9am or come before 4pm to pick up, I will need to be prepared to walk to find my child's group. I give my consent for my child to participate in weekly field trips that are scheduled to compliment the monthly program, under proper supervision. All field trips are posted and handed to me in the monthly schedules (including location, time of departure and return, and date). Any changes will be brought to my attention verbally or in writing.

I do give my permission to Live & Learn staff to administer bug spray, sting relief wipes, non-prescription hand/body lotion for dry skin, and sunblock to my child. I hereby give permission for Live & Learn Early Learning Center/ Live & Learn @ Mast Way to give my child simple first aid. When necessary I give permission for the emergency medical transportation of my child to a hospital or other emergency medical facility. I also give permission for my child to receive emergency medical treatment in the event that I cannot be contacted immediately.

"The licensing authority for this program is the Bureau of Child Care Licensing. Child care programs are required to post a copy of the statement of findings and corrective action plan for the most recent visit in a location which is accessible to parents, and must maintain copies of the statement of findings and corrective action plan for the preceding visit and make them available for parents to review upon request. "During licensing, monitoring, and complaint investigation visits to licensed programs the department shall speak with children regarding the care they receive at the program if in the judgment of the licensing specialist the children's response would be valuable in determining compliance with licensing rules. Licensing staff are experienced in working with children and trained to interview in a manner that is respectful and non-leading. However, if you do not want your child interviewed, or if you wish to be informed prior to your child being interviewed you must give the family child care provider, center director, site director or designee, and update annually, a signed dated statement indicating your preference."

I understand that any person or persons picking up my child from Live & Learn Early Learning Center/ Live & Learn @ Mast Way must have my written permission. The alternative pick up person must provide a picture id and sign out the child in classroom.
